### **Antonio Nieto-Rodriguez and Peter Monkhouse named PMI Fellows**

#### ***Long time PMI leaders win PMI's highest individual award***

The Fellow Award is the highest and most prestigious individual award presented by PMI, honoring professionals for their long and significant service to the organization and profession. The awards were announced at PMI's Virtual Awards presentation on 6 October 2021.



**Antonio Nieto-Rodriguez**, MBA, PMP is an author, practitioner, and consultant who teaches strategy and project implementation to senior leaders.
