The discussion was moderated by [Ms. Asiya Sheikh](#), Health Informatics Specialist at King Faisal Specialist Hospital and Research Center along with our esteemed panelists [Dr. Deepa Bhide](#), Director- Clinical Expert at IKS Health, [Mickey Nakamura](#), Transformation Executive & CIO Advisor at Pivot Point Consulting, a Vaco Company and [Michael O'Connor](#), Senior Research Program Director - Program Management at Medtronic.

The Panel Discussion commenced with an intriguing exploration of the transformation of Project Management (PM) and PMO roles in cooperation with the Healthcare Industry, all while probing into the entrance of AI and its collaborative potential across these three sectors.

The thought-provoking discourse revolved around the collaboration between PMO and Healthcare, the integration of Healthcare and AI, and the synergies between PMO and AI. A pivotal aspect of the discussion involved exploring the responsibilities and roles that PMOs can undertake to combat future natural disasters, considering the challenges the pandemic imposed on the healthcare workforce.

[Dr. Deepa Bhide](#), a distinguished individual with expertise in both medical and project management domains, shared valuable insights into the challenges faced as a Physician during Covid:

Dr. Deepa highlighted three primary challenges: managing patient lives amidst the pandemic's upheaval, ensuring seamless coordination in the face of overwhelming healthcare demands, and adapting rapidly to evolving medical protocols.

Amidst the adversity, a positive outcome emerged from Covid-19—the accelerated adoption of telemedicine and digital health solutions, enhancing accessibility, patient care and most importantly reassessment of priorities by the world's population like healthier habits and less risky behaviours.

[Mickey Nakamura](#), an esteemed panelist, emphasized leveraging PMOs' pandemic experience to drive innovation and business growth in the post-pandemic era:

Mickey envisaged PMOs as catalysts for innovation, harnessing the pandemic's lessons to foster agile, responsive, and adaptable strategies in the face of uncertainty.

The pandemic instilled the significance of robust crisis management practices, agile methodologies, and technology-driven solutions that PMOs must embrace to thrive in the future.

[Michael O'Connor](#), a visionary on the panel, explained about the upcoming adaptation of AI, ChatGPT and how they will be impacting the Project Management and Healthcare especially in the regulated industry of medical

devices development. And ensured how AI will enhance the role of PM and PMO instead of replacing them.

Beyond the panelists' individual perspectives, the discussion touched upon several crucial questions:

1. Aspiring PMs and PMOs were encouraged to prepare themselves for the healthcare industry's unique challenges by understanding the organizational priorities and by trying to connect the dots between services and care being provided to patients.
2. Nurturing specific skillsets was recommended to foster a deep understanding of clinical requirements and the ways in which PMOs can harmonize with the organization's strategies. Emphasizing thought leadership, displaying empathy, and, most importantly, adhering to OKRs were identified as key areas of focus.
3. Specific project management methodologies and frameworks have proven successful in the healthcare industry, with Requirement Traceability Matrix to track the projects right from the ideation till execution and again OKR steals the show.
4. Implementing AI technologies in healthcare projects mandates meticulous consideration of ethical use, data privacy, and patient safety, a responsibility entrusted to vigilant PMOs in this AI era.
5. Strategic PMOs were acknowledged as instrumental in driving innovation in the healthcare sector, fostering a culture of continuous improvement and creative problem-solving.

In conclusion, the Panel Discussion encompassed a myriad of insights, exploring the interconnected realms of PMOs, Healthcare, and AI in the post-pandemic landscape. It highlighted the critical roles of PMOs in shaping a resilient and innovative healthcare industry while being up-to-date with transformative technologies like AI. Together, these invaluable discussions contribute to shaping the future of Project Management in healthcare, fortifying organizations to navigate challenges with resilience and foresight.

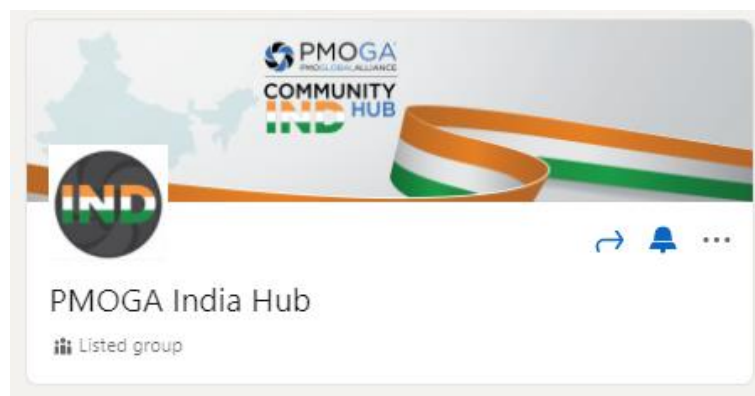
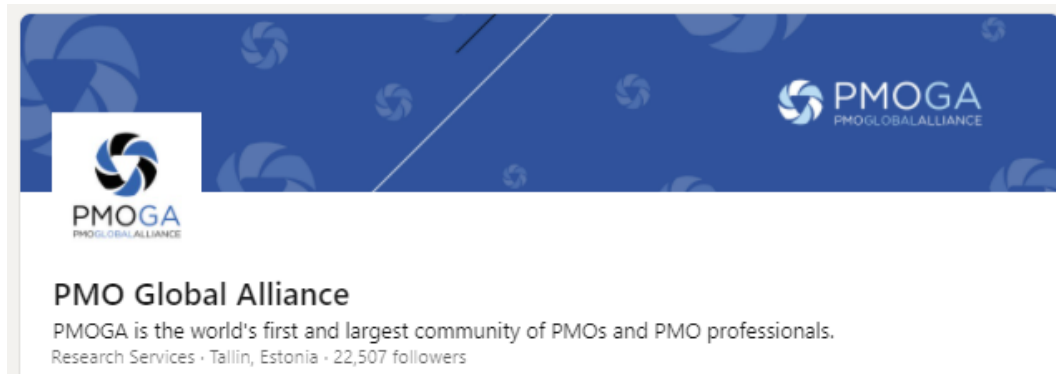
