

Introduction

Governments need projects to develop, preserve and produce wealth for their citizens, unlike defined projects that have a start and end date. Government projects are continuous and never-ending and driven by public needs which are endless. In some countries, government projects have a reputation for being poorly managed and perceived as being over-budgeted, taking longer to execute and not being completed due to lack of funding. However, over the decades, public project implementation has improved with the support of effective project management frameworks, standards, and best practices, in addition to an understanding of project governance, government structure, and the hierarchy of government agencies.

The book's cover has images of the globe and infrastructure projects which correlate with the title, Projects, Government and Public Policy. The objective is to describe the differences between Public Administration and Project Management, how the elements of government projects differ from private projects, and how the tools of project management can effectively execute projects aiming to enhance the livelihood of the public. The Author, Stanislaw Gasik, has defined projects, government, and public policy and how they are interrelated elements that shape the functioning of societies.

Projects represent planned endeavors to achieve specific goals, whereas government operations are instruments for formulating and implementing public policies that address social challenges. An effective public policy is a government action used to

achieve a specific goal that requires the collaboration of stakeholders while governments play a central role in governance and resource allocation. Together, these elements contribute to the development and progress of societies.

Overview of Book's Structure

The book starts by describing the differences between public administration and project management. The book is sectioned in five parts. The first part is written for individuals wanting to know about public administration and projects serving the public sector. The second part provides information on public administration concepts like public policies, instruments driving public policies and governance. The third part elaborates on how public projects differ from other projects and the success factors leading to a successful implementation of public projects. Part four describes the knowledge needed for effective public project implementation. Part five covers concepts of the maturity model and then follows with a description of methods for improving public projects.

Highlights

- Governments are project dependent and have the following serving branches organizations, ministries, agencies supporting the ministries, government enterprises, project implementing agencies and committees.
- Operations in public organizations are unlike in private organizations where it does not have clear goals and at times it has multiple goals where the ultimate expectation is to provide public value.
- Government operations are public policy instruments used to achieve a specific outcome; thus, public projects are important to drive change to an existing policy or are needed for implementing new ones.
- The difference between project-based and operation-based organizations is that organizations that are project-based only implement projects and those operation-based conduct routine activities. The first is project-based and the second is project dependent.
- The governance of public projects has a multilevel element to it where it is defined at the agency level and must be consistent with components at the government level.
- The success and failure of public projects depend on politics, stakeholders, human resources, early project phase, corruption, management methods, eternal environments and the public organization itself. A successful public project is evaluated for the following, how relevant it is, the need for the result, effectiveness and efficiency in implementation, the sustainable outcome, and its cost efficiency.

There are maturity models designed for measuring the performance of public sector projects and they are classified at the organizational and the government level. The Government Project Management Maturity Model (GPM3) can be used as a tool providing descriptive, comparative and prescriptive applications for improving public project implementation.

Highlights: What I liked!

The author presents a non-biased perspective of government activities which leads the reader to make their own judgment. The book is educational and backed up with references allowing scholars of project management to further explore the topic. The transition between sections of the book is cohesive. For example, to understand public projects one should read and understand public administration. The chapter discussing The Difference Between Public Projects and Projects of Other Sectors provides a clear difference not only in the strict regulations in project execution but also in the differences in qualities and personalities of a public service project manager compared to private sector project managers. The book provides hidden instructions on how to become a project manager for the public service sector.

The definition of government quality presented in the book fixated on delivering meaningful projects, exercising its power in public administration, its efficiency and effectiveness in achieving public policy goals and finding solutions and not creating problems by following set procedures and standards to not allow for corruption infiltration. Furthermore, government quality is measured by the good services it provides to its citizens and ensures their well-being. It is one "that solves problems faced by the government and society". For example, services that optimize access to affordable health services, facilitate citizen transportation and mainly prevent problems from occurring. Likewise, a good government would try to improve its administration by ensuring the availability of resources, administrative systems and procedures.

Organizational, management and political culture are necessary when considering effective governance. A good government manages its resources effectively and efficiently using effective project management tools to deliver sustainable outcomes set and designed as public policies regarding social goods and needs. Project implementation by the government is to be structured and must follow a set of instructions. Impediments to improving quality of life and citizen prosperity are due to the bad quality of government; hence, the quality of government is directly impacting the quality of citizens' well-being.

Who might benefit from the Book?



Impediments to improving government quality directly impact the quality of citizen wellbeing; thus, not only projects performance improvement must be a continuous process in the public sector but improving administrative systems and ensuring the availability of essential resources are critical for a successful government and a prosperous society.
